



BREAKING IT DOWN

When covid happened, everyone receiving a social assistance benefit started getting the entire benefit. Leah isn't sure what the full rate is for a four-person benefit, but for her and her daughter, it's around \$1300/month. Leah's not entitled to the full \$1300/month, though, and she doesn't know how to get the full amount either. But because no ODSP staff were working during Covid, everyone on any disability benefit got the full amount, even though they weren't eligible for the full amount.

When everyone went back to work again, disabled people started getting their regular rates, but each month, a little bit was being deducted to pay back the "overcharge". This isn't the problem. There's nothing wrong with this, other than we have no way to pay it back because no one will hire us.

Barrie Housing charges rent based on the amounts we received, so for Leah, her rent was increased to reflect 30% of \$1300/month, instead of the usual 30% of \$850/month.

Furthermore, in 2020, Leah was also receiving both the CPP Disability benefit, as well as the ODSP benefit. Although people with disabilities can be on both benefit programs at the same time, they can only receive monthly cash payments from one benefit. No one is entitled to cash payments from both benefits at the same time. The reason someone would want to be on both benefit programs, though, is because ODSP covers medical and dental and CPP Disability benefits doesn't.

ODSP also pays Leah's rent directly, so throughout 2020, ODSP just kept paying the BMNPHC directly and now she and thousands of other tenants on social assistance owe thousands to ODSP for rent that is being "paid off" to ODSP.

RENT-GEARED-TO-INCOME (RGI) CALCULATIONS

Leah's rent is calculated based on her income. Social assistance benefits are categorized as 'income deposits'. In 2020, between ODSP, CPP Disability, CERB and E.I., Leah received a total of \$30,947.07, the vast majority of which she has to pay back. She also can't get her ODSP financial breakdown to see how much was paid directly to her housing provider because the local office doesn't keep records that old, and apparently there's "nothing" the Simcoe County ODSP office can do to figure this out.

Leah's housing provider refuses to provide financial breakdowns to tenants who receive government assistance, and this is how they're able to "overcharge" tenants without them knowing it. Tenants are simply not given financial breakdowns and if they ask for one, they're simply ignored.

Another thing no one has noticed yet, either, is that Leah's CPP Disability payments stopped in mid-2020. But if you look at the 'Release Package' pdf attachment provided by Employment and Social Development Canada in their FOI request response, they told Leah that the number of CPP Disability beneficiaries hasn't changed since 2021. Why did the CPP Disability benefit take off a bunch of disabled people after Covid only?

CPP DISABILITY

Leah was removed from CPP Disability in September 2020, which can be seen on the following page. But this Freedom of Information (FOI) response from Employment & Social Development Canada says that the number of CPP Disability beneficiaries hasn't changed since December 2020, which means a ton of beneficiaries were removed right before December, or this information is incorrect.

There's also a good chance that these numbers are not correct. Did they really complete all their changes between September and December 2020?

Hello Leah,

Thank you for your email.

As requested, please see the table below for Ontario Works and ODSP cases and beneficiaries in Barrie and Innisfil for December 2021 and December 2022.

Upon reviewing the data, we realized that we had previously sent you Ontario Works data filtered for those served by the Ontario Works Barrie office, but this can include individuals who live outside Barrie, so we have revised this to those that live in the City of Barrie. This updated December 2023 data is included in the table below. We have also included Innisfil data for December 2023 for your reference.

Please also note that the Ministry and municipal service managers such as Simcoe may use slightly different definitions of active cases for a given month, which is the likely reason that the numbers you received from Simcoe were different.

The CCSS either stopped processing applications or they removed a whole bunch of disabled families from their disability program, just like the CPP Disability program did.

Note:

- A case refers to a single individual or a family unit on social assistance (e.g., a family on social assistance is counted as one case).
- The number of beneficiaries refers to the total number of single individuals and heads of family units on social assistance plus all their dependents (i.e., spouses, dependent children and dependent adults.



Leah organized the information that both the CCSS and Employment & Social Development Canada provided her in FOI request responses. Both respondents have prevented thousands of Barrie and Innisfil residents from not only not receiving disability by either removing them from the benefit program or not processing/accepting their application, but they've also done the same thing to the elderly in receipt of the Old Age Security benefit and the Canada Pension Plan.



The Ontario Ministry of Children, Community and Social Services, and Employment & Social Development Canada literally starved an entire population group; all low-income disadvantaged and vulnerable people in Simcoe County. And these numbers are just for Barrie and Innisfil. I can only imagine what they are for the rest of Simcoe County.
