Leah will also include another attachment of the parts of the PSI Foundation grant she wrote, for funds to pay her a salary to be a Project Manager for a research study.

4. What arguments support your claim that the Application has merit?
Leah has been trying to get employed since Jan/24. In Aug/23, Leah applied for a United Way grant to pay for her salary to operate a research study. In Feb/24, Leah presented to Alex Nuttall in his Office and asked to be hired as The Food Policy Director to run a Food Systems Planning Office. In Apr/24, Leah asked the the AAFC for a job. Leah's also been working (non-paid) with Dr. Orava at the BFMTU on a PSI Foundation grant, for a salary for Leah to be a Project Manager for a research study.

5. What harm would result if this Interim Remedy is denied and why does the balance of harm or convenience favour granting your request?

The respondents are responsible for Leah's inability to get employed and this is causing Leah to starve, not pay her bills, and experience excruciating mental health pain. Rob Cikoja, the CEO of Habitat for Humanity, told Leah, in-person, that the reason her charity would never get funded or supported is because Leah pissed-off The County with her social media posts (the ones the respondents hired their lawyer to threaten to sue Leah for defamation, even though Leah was publishing only pure truth).

6. Why do you believe it would be just and appropriate for the Tribunal to grant your request for an Interim Remedy in the circumstances?

This is the only public interest remedy that could ever possibly even begin to make right the crimes against humanity inflicted on an entire class of people, by the respondents, for decades. The most important thing, though, is changing legislation, and making sure that disadvantaged and vulnerable Canadians, especially women, aren't ever put in a position to be abused by government employees who get-off on annihilating their dignity, for any length of time, let alone decades on end, again!
