Petition to the House of Commons

Whereas:

- We the citizens of Canada have lost confidence in our government's ability to control, function and supervise certain portions of the Public Administration of the Special Priority Policy in every Canadian province.
- The current governments responsible for managing the livelihoods of victims of domestic abuse and trafficking are not protecting them against climate change.
- The policies and procedures of Regional Service Managers across Canada aren't aligning with the crisis victims of domestic abuse and trafficking are facing; unsafe housing and starvation.

We, the undersigned, **citizens and residents of Canada**, call upon the **House of Commons** to Issue an immediate emergency response plan for all low-income Canadians with Special Priority Status and an immediate transfer of the control, functions, and supervision of certain portions of the Public Administration of the Special Priority Policy to the Department of Public Safety and Emergency Preparedness Act.

Thank you! My head literally feels like an helium balloon and I have lost tons of weight 😊. By the way, one of the emails keeps bouncing back, so my apologies if you got my email more than once. I couldn't figure it out which one was it. Sending positive vibes to your way. Stay healthy!

Based on her response here, I had no idea she was upset about asking her to sign a petition.

So she emailed Barrie Housing about it:

Subject: Hello Soula!

Hello Soula!

As we discussed yesterday , I have compiled a summary of our conversation and sent it to you via email as per requested

In 2022 I applied for food assistance from Leah. In the questionnaire we must describe our situation and specify why support is required. I explained that I was not getting OW, that I'm the main caregiver of a child with Autism which prevented me from working and left me unable to afford food. She requested permission to share my experience to raise awareness for her food program. I say go ahead if it's going to help the cause.

She posted on social media an apparent correlation between food insecurity and Barrie Housing, but the statement was unclear to me...

Time goes by and the Program stopped running. Later, she contacted me again, stating that she added my name to a petition against Barrie Housing due to their alleged mistreatment of me because of my race.

I told her that Barrie Housing did nothing to me, that I do not give her permission to speak on my behalf and kindly asked her to remove my name from that petition.

I then reached out to Barrie Housing to address this situation. I am uncertain of the relationship between the two parties, but I wanted to clarify that Leah does NOT have the authority to speak on my behalf or include my name in any documentation, officially or otherwise.

I simply asked her to sign a petition. Many other tenants were happy to sign the petition, so I didn't need her to sign it, and I never wanted her to do anything she didn't want to do. I had no idea asking her to sign a petition was such a huge problem for her.

I just saw this text from her this morning, even though she sent it on July 27, 2024, not that it matters.

I don't know why she keeps stating that I'm not to speak on her behalf. I never tried to. I asked her to sign a petition.

Hello Leah!

I really need to ask... what do you think Barrie Housing did to me? I have never felt discriminated for being black or for having a child with special needs. My daughter receives ACSD which has absolutely nothing to do with Barrie Housing because it's through the Ministry of Children, Community and Social Services. My decision to file for bankruptcy is NOT attributed to Barrie Housing as I was in a much better economic situation before the pandemic. I really hope you're not speaking on my behalf as I have not granted you the authorization to do so.

As I mentioned before Barrie Housing has done nothing to me, so I wouldn't have any additional information to add to your petition. Barrie Housing is a nonprofit organization and they have to make money somehow. I don't expect to live in a rented unit for free because that's socialism, I come from there and I know how it ends. I really respect your decision to move forward with your petition and appreciate all your efforts you did in the past to help my family, but I cannot in good conscience put myself and my child at risk of losing everything with no potential benefit to gain.

She's clearly terrified of being evicted illegally and she was obviously worried I was going to say something to jeopardize her housing.

But all I did was ask her to sign a petition.

There's nothing wrong with asking her to sign a petition.

She blew this up into something way bigger than it was and now the respondents are attempting to make it mean something... I don't even know why they're trying to make it look like either.

The only thing this girl's letter does is prove the extreme level of fear she has regarding being evicted illegally, and this girl has tried very hard to communicate to Barrie Housing she did nothing wrong: She is not with me and she does not stand with me and she does not want to because she knows Barrie Housing will target her if she dares speak out against them.

She clearly became more worried about this happening as time went on.

My charity shut down in January, I couldn't have exchanged favours even if I wanted to; I had nothing to "exchange" by the time I asked her to sign the petition.

Thank you for being so grateful to me after everything I've done for you and your daughter. I will make sure to immediately submit all of the communications between yourself and me to all the respondents to show how much I did for you and what you just did to me.

Greetings everyone!

My name is [REDACTED]. Unfortunately, I have been subject to harassment by Leah Dyck, who initiated a petition against Barrie Housing without obtaining my consent to include my name. Upon my request she removed my name.

Days later she contacted me to suggest that I should join her to pursue legal action against Barrie Housing, citing discrimination based on my ethnicity and my child's disability.

I communicated with Barrie Housing via email regarding the situation and emphasized that Leah Dyck is not authorized to speak on my behalf. Following my notification to Barrie Housing, Leah Dyck continues to harass me and my daughter.
