Good morning, can you explain to me how you figure out if housing is stealing money from tenants? I've tried going through all your posts, but I don't understand a lot of it. I lost my ODSP in April as my family dr went MIA - end when renewal happened, with no income, my monthly rent went up, even though I have zero income

Everyone wants to know if they were overcharged because no one was provided with tenant ledgers.

How does rent go up if someone has zero income?

Oh well, I guess she can just get evicted then, and if she tries to tell anyone, they ignore her or acuse her of lying. Hi Leah,

I just read one of your posts about being over charged for rent geared to income. How did you figure this out?

A completely different issue all together but still something my sister and I have been wanting to somehow address is the amount of people who are over housed and taking up space for women and children who really need it.

For example: my sister's neighbor is an elderly woman who is unable to care for herself and should be in an assisted living facility, however, she is living in a 2-3 bedroom townhouse by herself! I brought this to the attention of my worker and her response was there just isn't enough housing and we can't kick people out of their home. While I agree to both, there is definitely a crisis shortage of housing and we cannot kick people out of their homes we certainly can make sure that people are not taking up more housing than they require.

Would love to hear your feedback on this and if you are interested in trying to pursue this further with me?


